The Random Reward class is for any dog that is capable of performing the exercises in that level class and is eligible under the Obedience Regulations to compete in AKC events. No title is required to enter and handlers may enter more than one dog. Dogs in the class may be handled by the owner or any other person, and may be entered in additional class or classes. - 2. Consult Judging Program for time of judging. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.
- 3. Exhibitors must have their dogs use the identified Exercise Area outside the trial facility and please clean up after their dog. Should your dog have an accident inside the facility please ask for cleaning supplies.
- No RV overnight parking available at trial site.
