(coats, blankets, etc) If in the opinion of the inspection committee any entry is found to be lame, unfit to compete or in season they shall not be allowed to run and the applicable entry fees shall be refunded.

Practice Runs: Practice will be held when no test participants are waiting. \$10.00 per practice run.

<u>Running Your Dog:</u> It is recommended that dogs be handled with a "slip-lead" that gives an instantaneous freedom to the dog when "Tallyho" (release) signal is called by the Huntmaster.

Dogs may run with or without any collar for safety reasons. Unacceptable collars are choker collar, a collar with prongs or an electronic training collar.

Owners may use a rubber band to hold the dog's hair from their eyes. The owner assumes responsibility for the safety of the dog with regard to the dog's collar and paraphernalia on the dog.
